## LEBANON CITY COUNCIL MINUTES April 11, 2022 @ 6:30 p.m.

The council met in regular session at city hall. The meeting was called to order at 6:30 p.m. by Mayor Wright.

Roll Call: Alderperson Duckworth, Fero, Mack, Wilkins and Witty – present Alderperson Bennett, Mack and Roma – absent

Followed by the reciting of the Pledge of Allegiance

Alderperson Fero/Duckworth Motioned to approve the omnibus agenda as presented.

MOTION passed 6–0

Alderperson Bennett entered the chambers at 6:32 p.m. during the vote on the omnibus agenda.

#### **Audience/Citizen Public Form:**

## **PLAN COMMISSION REPORT:**

Chair Brent Wood presented information from the 4/7/2022 Plan Commission Meeting including recommendations for council to approve following items:
