LEBANON CITY COUNCIL MINUTES August 14, 2023, at 6:30 p.m.

The council met in regular session at city hall was called to order 6:30 p.m. by Mayor Wright.

Roll Call: Alderperson Branch, Davis, Fero, Trinka, Washington and Witty - present

Following the Pledge of Allegiance Alderperson Fero/Witty Motioned to approve the omnibus agenda, which included the agenda, approval of the bills and minutes from July 24, 2023 council meeting and the July 24, 2023 Executive Session minutes.

City Clerk Holper administered the oath of police officer to the city's newest officer Andrew Lampe

Audience -

1. Chris Koenig spoke to the council concerning the occupancy requirements for running a business out of a shed located on McCleary property. The occupancy permit for a commercial building has the requirement for an inspection when property is sold, or a different business occupies said property. The inspection for a commercial building requires water, sewer and electricity to be in working order. Mr. Koenig was heard to use profane language and the city attorney asked Mr Koenig to be removed by the Chief of Police. Mr. Koenig left on his own accord.

1. Alderperson Trinka questioned what will happen with the headstones damaged by the falling of a tree in the cemetery.

- 2. Plan Commission recommended denial of the "door" signs for Momma's House as they fell outside of the allotted coverage as they are 100% coverage. The PC tried to work with Momma's House to see if they could come up with a solution to get them within coverage compliance. Momma's House didn't attend and told the PC representative (AJ Dontigney) that "An ordinance does not have the weight of a law and that he did not have to follow that ordinance. The PC voted unanimously to recommend the denial of the signage on the doors. Along with the denial they turned over the enforcement to the City Council, as they do not have that authority. Alderperson Fero/Witty Motioned to approve the recommendation of the PC to deny the COA for the doors at Momma's House because of coverage violation.
